
Lies of Evolution: Grand Canyon




Figure 13–11 The Colorado River, flowing along the bottom of the Grand Canyon, has cut through layer upon layer of rock over millions of years, exposing fossils long buried in sedimentary rock.

The Colorado River travels through the Rocky Mountains. The river's elevation, when it enters Grand Canyon, is 2800 ft. It flows downhill and exits the canyon at 1800 ft. The highest points of the Rocky Mountains (Kiabab Uplift) are 6900-8500 ft elevation.

Considering these altitudes, we should notice the following points:

- 1. The top of Grand Canyon is higher than the bottom.
- 2. The river only runs through the bottom.
- 3. The Rocky Mountains are higher than where the river enters the canyon by over 4000 ft.
- 4. Rivers do not flow uphill.





Unless rivers in nature can be shown to flow uphill against gravity, there is no way that river made that canyon. In all respects, Grand Canyon is quite obviously a breached damn on much larger proportions than we are used to seeing.

All it takes it one tiny crack in the dam, and the whole thing comes crashing down very quickly.


Evolutionists are teaching that canyons form with a little bit of water, and a lot of time. However, here we can see an example of an enormous canyon forming very rapidly with a lot of water and little bit of time. However, a rapid formation explanation from a breached dam can be observed naturally, and is scientific observation.

From a Biblical worldview perspective, the Grand Canyon was mostly likely not made during the Global Flood of Noah, it was made sometime afterwards. Dr. Walter Brown, engineer from MIT, has analyzed current maps of the region and discovered old beach lines where two giant lakes used to be, and drained out to form the Grand Canyon.

As the flood waters subsided, large pockets of water (lakes) would form on the newly formed continents. Most of the mud from the canyon probably washed out in the first few hours, and continued to drain for the next few days or weeks, until it resembled the slow-moving river we see today. The river forming the canyon slowly over millions of years not only defies logic, but is also a complete assumption that is based on first assuming evolution is true in order to claim there is evidence for evolution.



Scientists can look at Mars and see giant canyons, far greater in size than Grand Canyon, and conclude there must have been an enormous amount of water in a short amount of time to create that canyon. Yet, evolutionists will deny that same conclusion when they can stand face-to-face with Grand Canyon because an interpretation of a lot of water and little time matches too closely with the Biblical explanation.


A river slows down considerably as it empties into a lake or an ocean. The place where a river flows into a larger body of water is called the **mouth** of the river. <u>Sediment settles out at</u> the river's mouth. Eventually, the sediment builds up above the water level and forms a fan-shaped area of land <u>called a delta</u>.

Another problem with the evolutionary explanation is the lack of mud at the mouth of the Colorado River. (The mouth is where the river exits into a larger body of water.) As rivers flow, they carry sediments downhill to the mouth and deposit them there, leaving behind what are called 'deltas'.





Yet, the Colorado River delta is only about the size of the state of Rhode Island (about 3,000 square kilometers).



The Mississippi River is minor in comparison to the amount of mud that should have washed out of the Colorado River, and likewise there is nowhere close to a fraction of the amount of mud that should be in the Colorado River delta. One can make up as many stories as they want to try and explain this away, but the fact is that we do not find the expected patterns for the evolutionary model.

The average evolutionist does not consider that there are *NO EROSION MARKS* between the layers of rock in Grand Canyon. **Don't you think it would have rained once in a million years**? The compression of layers, with no erosion marks between, indicates that these layers all formed at the same time, and we have no indication whatsoever that they built up

over hundreds of millions of years.

If someone wants to *BELIEVE* that the Colorado River formed the Grand Canyon over millions of years, despite that river don't flow uphill, despite that there is hardly any mud at all washed out of the river, and despite no erosion marks expect for long time periods, he/she is welcome to believe it, but it is not science; it's religion. The existence of these religious ideas about evolution being taught as fact in our public school text books is a lie, and we need to keep that religion out of our schools.
